And whereas; the current Parcel A is only zoned C – commercial due to the previous existence of a service station located on Parcel A, and has remained with such zoning through several iterations of the R. M. of Blucher's No. 343 Zoning Bylaws as there has been no change in the use or intensity on or of the parcel.

And whereas; the current Parcel A, NE 32-36-3 W3 is considered a non-conforming use or intensity of use as it contravenes Part III, Section 3.4 b) 8) of Bylaw 3-2001 The Basic Planning Statement of the R. M. of Blucher No. 343.

And whereas; Section 89 (2) of *The Planning and Development Act* states "Any future use of the land or building must conform with any current Zoning Bylaw".

Therefore be it resolved that the Council of the R. M. of Blucher No. 343 hereby refuses the subdivision application as it will increase the intensity of the commercial use on said Parcel A, which is already a non-conforming use, and is in contravention of Part III, Section 3.4 b) 8) of Bylaw 3-2001 and Section 89 (2) of *The Planning And Development Act*, 2007.
